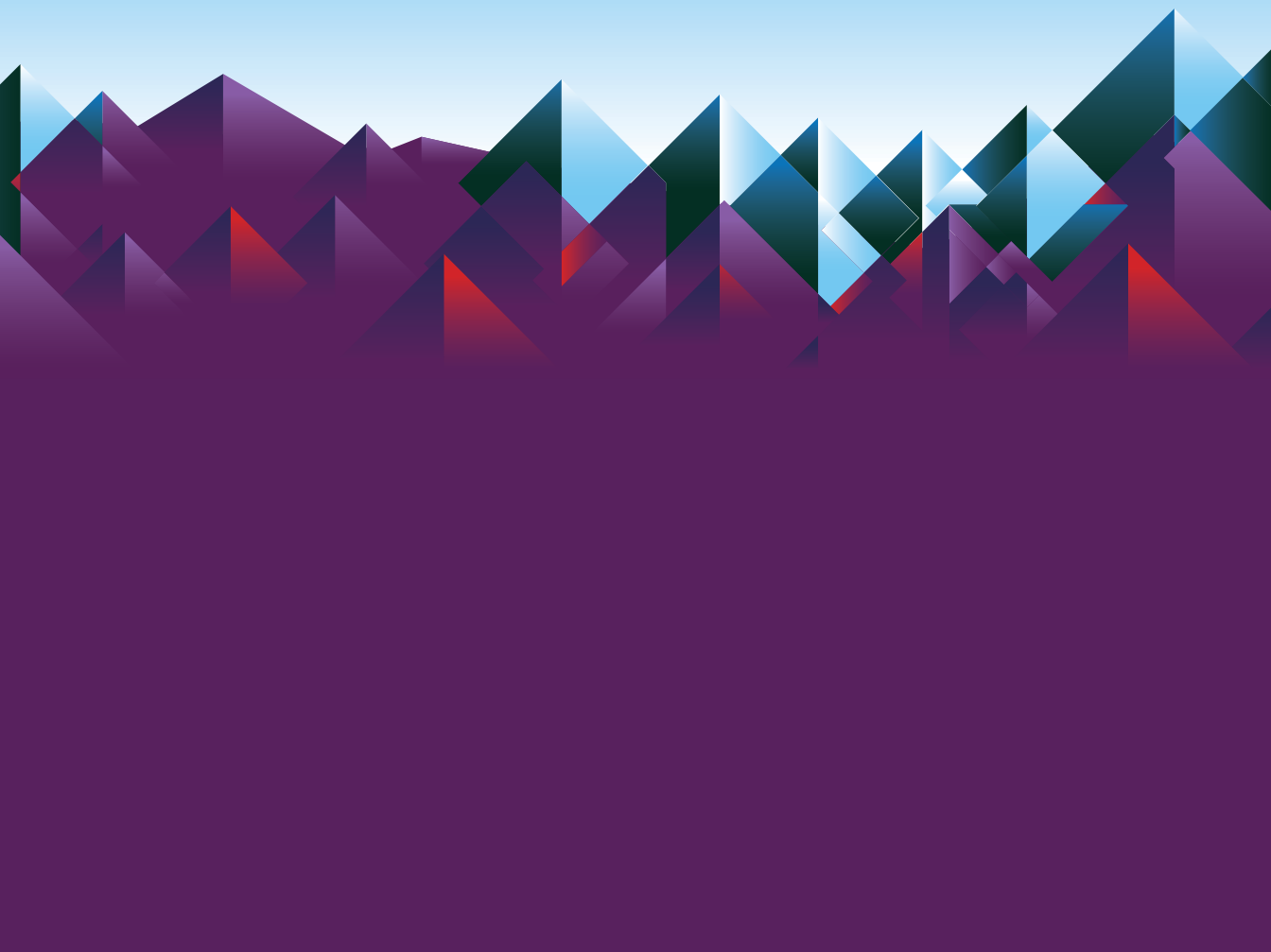

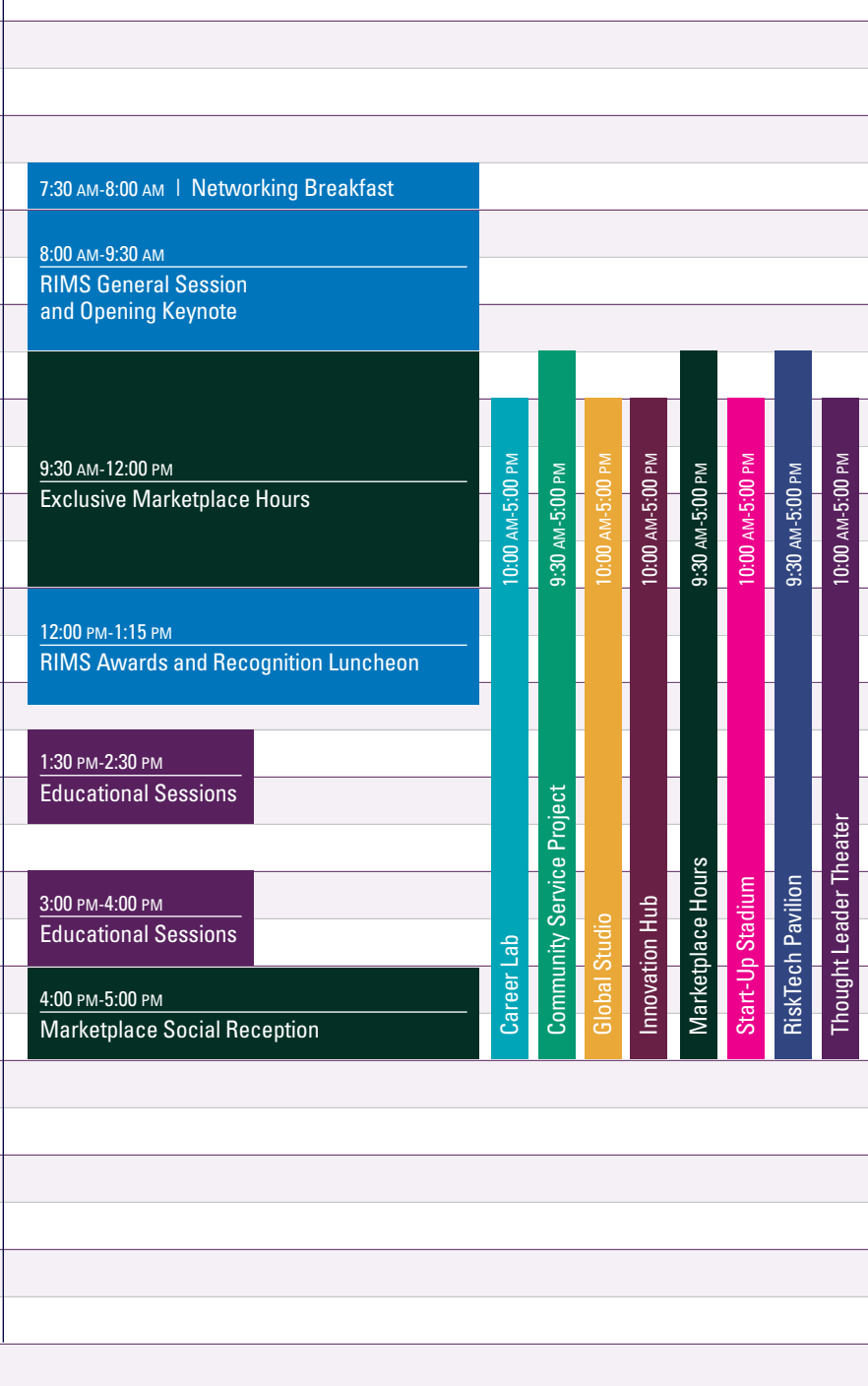

As founder and CEO of Mindset Digital, Debra Jasper, PhD, applies her deep passion for powerful storytelling to helping professionals capture attention in a digital age. Debra spent more than a decade as an award-winning journalist, covering presidential campaigns and state politics, and producing in-depth, investigative projects. She earned two degrees in journalism, along with a PhD in Educational Policy and Leadership.

CLASSICAL VIOLINIST AND INNOVATIVE COMPOSER

Kai Kight uses music as a metaphor to inspire individuals and organizations across the world to compose paths of imagination and fulfillment. Inspired by his own mother who, when diagnosed with cancer, revealed regrets of not bringing her ideas to the world, Kai is on a mission to spark a global mindset shift in which ingenuity is the norm, not the exception.

A product of Stanford University's design and engineering program, Kai remains fascinated by the leaders, artists, and companies who dare to be different. As both a Mayfield Fellow and Kleiner Perkins Design Fellow, Kai has proven himself as a leader of the next generation of innovative and entrepreneurial talent. As a musician, Kai has performed his original music for thousands in venues across the world, from the White House to the Great Wall of China. As a speaker, he has created impactful experiences for audiences at conferences, companies, and universities internationally. RONAN FARROW

PULITZER PRIZE-WINNING INVESTIGATIVE REPORTER

Ronan Farrow is an influential voice in government and media, helping traditional institutions address the frustrations—and tap into the promise—of a new generation. Forbes Magazine has twice named him one of the “30 Under 30” most influential people in law and policy, a contest he has gone on to judge. In 2018, he won the world's most prestigious journalist award, the Pulitzer Prize, for his reporting on sexual harassment by Harvey Weinstein. He is the author of the New York Times best seller *War on Peace: The End of Diplomacy and the Decline of American Influence*, which gives a unique insight into U.S. foreign policy, and what many describe as U.S. resignation in global leadership. In this book, Farrow interviews all of America's former living secretaries of state.

Farrow served as a State Department diplomat in Afghanistan and Pakistan, and reported to Secretary of State Hillary Clinton as the United States' first special adviser for global youth during the Arab Spring revolutions. Farrow is a Yale Law School-educated attorney and a member of the New York Bar, and attended Oxford University as a Rhodes Scholar.
